
Pre-Approval/Pre-Qualified and Approval Letters Must Meet the Following Guidelines:

1. Must be on lender letterhead
2. Dated within 30 days of the bid date
3. Signed by loan officer
4. Must state credit has been reviewed and approved
5. Must state that a written application has been made
6. Must state loan amount
7. Must include name of purchaser
